

WALBERSWICK ANNUAL PARISH MEETING
14th SEPTEMBER 2021
VILLAGE HALL, WALBERSWICK

Minutes of the meeting held Tuesday 14th September 2021 at 7pm.

Present: Cllr. Andrew Lewis (Chair of the Parish Council) and Mr. Mark Knight (Clerk to Walberswick Parish Council) and 31 electors of the Parish.

1 Chairman's welcome.

The Chair welcomed those present to the meeting. It was stated that all reports had previously been submitted and are available alongside these notes and the agenda for this meeting on the Parish Council website in full.

2 Apologies for absence.

It was reported that County Councillor Richard Smith and the representative from the RNLI would not be present as hoped.

3 To consider the minutes of the Annual Parish Meeting held on 6th May 2021

The Chair confirmed that the minutes were a true representation of the meeting and also gave a brief verbal report on the logistics of holding this meeting virtually.

The process of becoming a Corporate Trustee was explained and a full report on the activities of the Charity and how they are governed, such as administration, environmental stewardship, maintenance, was given.

It was noted that the assets and liabilities of the Chairty were held in trust and governed ultimately by the Charities Commission.

However, the current definition of Trustee as defined by the constitution does not mean that the Chairty is a legal person and is not able to enter into contracts, employ staff which becoming a Corporate Trustee would allow.

It was stressed that the structure of the Charity would not change but by becoming a Corporate Trustee and will not impact on the responsibility or accountability of the appointed Trustees. But that there would be changes to who appoints trustees and the terms of these appointments as well as how these trustees would be appointed.

The focus would also remain on the relief of need in the village specifically to the residents of Walberswick and a more general need to those visiting the village.

Details of the good done by the grant awarding process was also noted.

It was finally noted that there was currently one vacancy on the board of Trustees which would hopefully be filled soon.
